6. Correspondence To:

- a. Terry Diehl and Audrey Hall led a discussion on the effort to improve the quality of football officiating. Inconsistency and controversial calls were questioned during the 2009 playoffs. A handout was presented and the following steps will be taken.
 - (1.) The officials met to discuss the controversial calls and reviewed the game CD's and admitted that mistakes were made.
 - (2.) Football crews will be evaluated two times in the 2010 season, during September and October. Tape/DVD of evaluated games will be reviewed by chapters. They will analyze, discuss, and self-evaluate the officiating.
 - (3.) The evaluations will emphasize sportsmanship, professionalism, rules and hand signals, communications, and preventative officiating.
 - (4.) The same evaluator will evaluate the crews both times to be consistant. Each official will be given a score/rating from 0 to 100. The best official at each particular field position will be selected for playoff games.
 - (5.) District 5 will pay an evaluator a maximum fee of \$50.00 per game for the football crew evaluations for 2010 only. In 2011 the football crews chapters will have to pay for the evaluations. Terry Diehl will check on the cost of the evaluations. Dan Sullivan will be one veteran evaluator who will be asked. Motion-Hall, Diehl.
