  - 4. District competitive cheer competition.
  - 5. The school board rep position is open on the district committee. Individuals interested must work through the state association.
  - 6. District Football

    - AA Bedford, Chestnut Ridge, and Westinghouse will form a region. District 9 with four schools will form a region. The winner of Bedford and Chestnut Ridge will play Westinghouse in Pittsburgh week 12. District 9 winner will then play 5,8 winner in district 5 week 13.
  - 7. <u>District Basketball</u> District 5 will play District 8 at Bedford or Somerset, boys and girls.
