5. Correspondence To:
 - a. Letter from Fannett Metal concerning the participation of Path Valley Christian School students in varsity cross country. They are not a PIAA member school and do not have PIAA approval. They have no co-op with Fannett Metal. Motion approved that if they want to participate, they should become a member of the PIAA and seek a co-op with Fannett Metal. Motion - Kudlawiec, Scott.

 - a. Acceptance of Chestnut Ridge Soccer and Volleyball Rules Exception Authorization Letters from the PIAA for uniform modifications. These are religious modifications.
 - b. Approval of request of the Inter County Conference to conduct a Junior High Wrestling Championship Tournament the first weekend in February. Motion - Thompson, Diehl
7. Discussion Items:
 - a. Discussion of disqualification responses to sport chairmen. Coaches and players have to accept disqualifications. There is very little chance of change. The officials have 24 hours to report disqualifications. Some are delinquent.
 - b. Approval for the District Five Athletic Director's Association to conduct drawings at District Five Championship Events to raise funds for District Five Student Athlete Scholarship Awards. They presently award six \$1,000.00 scholarships to students. Motion - Kiesnowski, Shoemake
 - c. Approval of payment for students and parents meals at the April meeting for the presenting of Scholarship Awards. Motion - Shirley, Thompson.
 - d. Discussion of problems of travel time and distance to non-adjacent districts for the sub-regional playoffs. This creates problems especially for Somerset and Bedford. We need to work toward having playoffs as near as possible to each district and to seek alternate sites each year.


