6. Correspondence From:

- a. Request from Bedford and the Laurel Highlands Conference to hold a conference wrestling tournament. District 6 has approved it. No competition points to be counted. Motion to approve- Diehl, Leonard
- b. Jr. High Football Co-op Forbes Road and Southern Huntingdon. Motion-Hall ,Cronrath 7. New Business;
 - a. Discussion of individual ranking for the district tennis tournaments. A win is a win. We must accept the ways leagues play their format. Some play a 3-2 format, some a 5-2 format, and some a 4-3 format. Some allow individuals to play both singles and doubles and some allow to play only one. Seed on the total record.
 - b. Football AA and AAA Playoffs.
 - (1.) AA Bedford, Chestnut Ridge, and Everett will declare a district 5 champion on week 11. Winner will play district 8 Westinghouse on week 12. Winner plays District 9 week 13.
 - (2.) AAA Somerset will enter a sub-regional with districts 6,8,9.
 - c. Northern Bedford's football schedule will show them playing District 9 AAA Bradford, Clearfield, or Punxsutawney on the 10th date. They will play the 3rd place school.

 - f. Basketball brackets for District 5 Boys AA and Girls A are being worked out yet. In boys we will be involved with District 8 Westinghouse the next two years. 1st year Maybe have our championship, then have 5-2 play Westinghouse. 2nd year 5-1 plays 8-1 to get in.
 - g. The District Committee will pay the PIAA School Dues for all district schools for 2012-2013. Motion- Cronrath, DeMarco.

8. Discussion Items:

- a. Cross Country will have 3 classes for 2012-2014. Everett and Southern Fulton will need to terminate their co-op by the May meeting.
- b. The Somerset County Principals have re-appointed Ralph DeMarco for the 2012-2013 school year and Fulton County/ Fannett Metal have to select a Superintendent rep.
- c. Golf and all other brackets need to be examined by sport chairmen.
- d. The date, time, and location for the June meeting will be decided at the May meeting.
- e. District 5 Handbook Updates for 2012-2014 and Individual Sports Packets for 2012-2013 will need to be worked on for the May and June meetings by the committee.
- f. The state school code will absolutely not be amended to establish boundry and non-boundry schools. This is a blow for the public schools.
- g. All schools and football coaches be aware of possible major changes maybe coming in the heat acclimation period for football.
- h. The PIAA Volleyball format is not set yet. Dawn Maluchnick and Mr. Palumbo are to vote for a format. Motion- Maluchnick, Hall
- i. All spring sports awards are here for spring sport chairmen to take.

8. Discussion Items (continued):

- j. The PIAA Board of Directors rejected a proposal of the Executive Director that only PIAA Districts with at least 50 member senior high schools would have a voting representative on the Board of Directors. This was an attempt to have the board look at state re-districting to create probably 8 districts and to merge the smaller districts with larger districts. We would have probably merged with district 6 and would have lost our identity. This still could happen in the future.
- k. The PIAA will begin a State Cheerleading Championship in 2013. Details are still being worked on and some policy changes will still be decided. The present possible format includes the following:
 - (1.) A date of the 1st Saturday in February, a one day format.
 - (2.) Two classes of Large Varsity (17 and over members) and Small Varsity (Less than 17 members), and maybe three with a co-ed class.
 - (3.) 40 teams in each class, maybe by district allotment or maybe first come with an entry deadline.
 - (4.) An entry fee of \$100.00 for each school.

Many questions remain yet and a lot of details need to be worked out. Stay tuned.

- I. The basketball and wrestling tournament chairmen were praised for running very successful and well run tournaments.
- j. Schools and Athletic Directors need to check the list of PIAA officials very carefully to keep aware of officials removed by PIAA action. The schools are responsible.
