7. Discussion Items:

- a. There will be six teams in the 2014 district cheerleading contest. There will also be a mascot contest.
- b. District 5 passes were distributed to school superintendents and board members. A discussion of district event comp tickets was also held. District schools are to be more in control of issued complimentary tickets.
- c. A discussion of district 5 track records was held. Presently, our only district records are records set at the district track championship meet. Should these be the only official records or should we have records set at any district schools events? This will be difficult with the different track situations and different track timing systems. More thought and discussion is necessary on this.
- d. Beginning in 2016 all state coaches will be required to take a Coaching Education Course. Education courses are available through the NFHS and PSADA. Jeff Batzel is qualified to teach the NFHS course. The committee will be working on a plan to train all district 5 coaches, including volunteers.
- e. Tie breaking system for 8th place games. The committee decided if two or more are tied for 8th, a playoff game will be held, irregardless of record. The handbook wording; "If schools with records have less than a .500 record and are tied for the last slot on the playoff bracket and have the same rating points, playoff games will be scheduled at neutral sites in all sports except football." After much discussion, at 6:10 Terry Diehl made the motion that Taylor Cahill and Toby Cahill requests for athletic eligibility transfers from the Conemaugh Twp. School District to the Berlin Brothersvalley School District be granted. The motion was seconded by Lori Seth. By a committee vote of 10 -1 the transfer requests were approved and granted immediately. Both schools were praised by Chairman Palumbo for the conduct of the hearing.
