### DISTRICT TOURNAMENT-RANKING AND PLAYOFF 2025-26 INFORMATION

- 1. Ranking is determined by total points accumulated divided by the total games played. (Excluding tournaments, scrimmages, and exhibitions).
- 2. A minimum of eight schools will advance into the Class A playoff. All member schools in class AA are eligible for playoffs.
- 3. First round competition will be as follows:
  - 1 vs 8 2 vs 7 3 vs 6 4 vs 5 All games played at highest ranked team! Class A teams with 500 record or better will qualify for the District Playoffs. Play-in games will be 9 @ 8, 10 @ 7, 11 @ 6 ....
- 4. The District V cut-off date is Monday, October 20, 2025. IF a play-in contest is necessary, the date for that contest is set for Tuesday, October 21<sup>nd</sup>, 2025.
- 5. All competitions prior to the District V Championship will be played at the higher seeded team's home field. The District V Championship will be played at a neutral site. Pending extenuating circumstances, this is subject to change through the District Chairman and sports chairman.
- 6. Semi-final winners will advance to the championship game to be played at a neutral site, unless Teams 1 or 2 do not play in the first round.
- 7. For championship play, it is strongly preferred that championship contests be played on an artificial turf field (either Somerset or Windber).
- 8. The tournament director will contact the Principal and/or the Athletic Director of both schools prior to establishing the playoff site. Any feedback from participating schools regarding the semi-final and final site must be faxed directly to the tournament director within 2 hours of initial contact. The tournament director will relay any feedback to the District Chairperson (Paul Leonard), who will make the final decision on neutral site selections.

### P.I.A.A. DISTRICT 5 POINT SYSTEM

- 1. Please refer to the District V Handbook for the updated point system.
- 2. No points are awarded for a loss regardless of opponent's classification.
- 3. Victories over non-PIAA or out of state opponents are addressed in the PIAA V Handbook.
- 4. Tournament games, scrimmages, and exhibition games do not count in rankings.
- 5. Forfeiture of a contest will be governed by PIAA regulations.
- 6. Rankings will be based on all schedules declared on August 15th, 2025.

### TIE BREAKING SYSTEM FOR RANKING ONLY APPLIED IN ORDER

(Tournament games will not be used in any of the criteria listed below)

1. Head to head victor, if the teams played each other.

- 2. Winning percentage versus all common opponents in all games played (regardless of the number of times two schools play each other).
- 3. Bonus points as calculated by wins by defeated opponents divided by games played.
- 4. Winning percentage calculated by wins divided by games played. Ties count as half.
- 5. Greatest number of wins, excluding tournaments, scrimmages, and exhibitions.
- 6. Coin toss at site convenient to both schools.
- 7. If schools with records less than .500 are tied for the last slot on the playoff bracket and having the same rating, playoff games or matches will be held at a neutral site. Applies to all sports except Football.

### Rules applicable to Mixed Gender Teams:

- Because PIAA does not have a Mixed Gender classification, the following provisions govern participation by Mixed Gender Teams:
  - o For Post Season purposes, Mixed Gender Teams (other than in the sport of Spirit) shall compete only in the sport classifications designated for boys.
  - o For enrollment classification purposes, a Mixed Gender Team shall be classified by using the school's enrollment number for whichever gender constitutes a majority of the Team members.

Please refer to the District V Handbook for current gate fees for playoff contests and means for entry payments.

Playoff Times – All contests are set to begin at either 4:30 or 7:00 PM unless a time change is approved by the District Chairperson.
