PIAA MISSION STATEMENT

The mission of the Pennsylvania Interscholastic Athletic Association, Inc. (PIAA) is to serve its member schools and registered officials by establishing policies and adopting Contest rules that will emphasize the educational values of interscholastic athletics, promote safe and sportsmanlike competition, and provide uniform standards for all interscholastic levels of competition.

THE DISTRICT 5 COMMITTEE

According to Article V, Section 1 of the PIAA constitution, District 5 will encompass the member schools in the following counties: Bedford, Fulton & Somerset and part of Franklin (Fannett-Metal School District).

- Two** (2) Officials' Representative
- One** (1) Girls' Athletics Representative
- One** (1) Superintendent – alternate every three years (3 year term begins 7/1/2024) from Bedford County. Current term expires in 6/30/2027. Next Term from Somerset County followed by Fulton/Franklin Counties.
- Two** (2) Parent Representatives - alternate every three years (3 year terms begin in 2006)
 - 1. Somerset County (Male) current term begins 7/1/2024 and expires 6/30/2027. Next Term (Male) from Fulton/Franklin Counties followed by Bedford County
 - 2. Fulton/Franklin Counties (Female) current term begins 7/1/2024 and expires 6/30/2027. Next Term (Female) from Bedford County followed by Somerset County
- One** (1) Representative from Member Private School

ADVISORY MEMBERS OF THE DISTRICT 5 COMMITTEE

Non-voting members serve at the will and discretion of the District 5 Committee. All non-voting members must be endorsed by their home school to serve as a non-voting member. The District 5 Committee may also appoint previously elected committee members as advisors of the District Committee who also serve at the will and discretion of the Committee members.

DISTRICT COMMITTEES

SECTION 1. COMPOSITION

A. Committee Makeup. The makeup of each district committee shall be decided by the members of that particular district; provided that at least one member of the district committee shall be a representative of the junior high/middle schools of the district, one a representative of the school boards of the district, and one a representative of the registered P.I.A.A. officials in the district.

Additionally, each district committee shall contain an advisory representative of the athletic directors of the district, and an advisory representative of the girls' athletic programs in the district.

B. Method of Selection.

1. The members of schools of a District shall approve each year from their district, at their annual meeting, members, at their discretion, to serve for one year except the Junior High/Middle Schools representative, who shall serve for a period of two years, starting the following July 1st, all of whom shall be professional employees certificated by the Pennsylvania Department of Education.

2. The school board member, whose high school is a member of the P.I.A.A. , shall be appointed for a term of two years by the Board of Directors of the Pennsylvania School Boards Association from each of the P.I.A.A. geographic district areas.

3. The officials' representative shall be elected for a term of two years by the P.I.A.A. registered officials of the District. When there is only one nominee for an officials position in a District, an election will not be conducted, and the nominee will be elected to the position. Representatives of odd numbered Districts will be elected in the odd numbered years and representatives of even numbered Districts will be elected in the even numbered years.

C. Time of Selection

All elections and appointments shall be made prior to May 8th

D. Vacancies

When a vacancy occurs in the membership of the District Committee, the unexpired term shall be filled by the remaining members of the committee, except that in the case of the School Boards representative, the Board of Directors of the Pennsylvania School Boards Association shall appoint an interim representative to fill the unexpired term; and in the case of the officials' representative(s) the Executive Director shall conduct a special election among the affected PIAA-registered officials of the District to fill the unexpired term(s). District 5 committee members elected to serve on the district committee whose employment status changes will remain on the district committee for the remainder of their term.

E. Organizational Meeting Requirement. The members of each District Committee elected for the following year shall meet for organization purposes only, prior to May 8th.

F. Failure to Elect. If a district fails to elect a District Committee prior to July 1st, the President of the P.I.A.A. shall appoint a chairman from the district who shall serve during the ensuing year. He shall conduct an election for the remaining members of the District Committee within one month following his appointment.

SECTION 2. OFFICERS

The officers of each District Committee shall be a Chairman, a Vice Chairman, a Treasurer and a Secretary, or a Secretary-Treasurer combined.

SECTION 3. POWERS AND DUTIES OF A DISTRICT COMMITTEE

The District Committee shall have the following powers and duties subject to exercise by the Board of Directors of its powers as provided in Article VII, Section 1 of the PIAA Constitution and By-Laws.

- A. To have general control within the District over all interscholastic athletic relations and athletic contests in which a member school participates, subject to the provisions of the rules and regulations of the Board of Directors.
- B. To elect its own officers and establish rules of procedure
- C. To administer the finances of the District Committee
- D. To render, within the District, an opinion on the provisions of the Constitution and By-Laws, Policies and Procedures and Rules and Regulations of this Association.
- E. To decide matters in dispute between member schools located within the District. No member of the District Committee shall be eligible to vote in case of a dispute involving such member's school.
- F. To receive, request, or require data on alleged violations of the Constitution and By-Laws, Policies and Procedures and Rules and Regulations by or from schools located within the District. In assuming this responsibility, the District Committee shall not be required to assume the position of investigator. Charges of violation against the Constitution and By-Laws, Policies and Procedures and Rules and Regulations of this Association by a member school shall be made to the Chair of the District Committee, such evidence shall be presented in the form of affidavits.
- G. To make determinations as to the eligibility of contestants, and to address alleged violations of this Constitution, By-Laws, Policies and Procedures and Rules and Regulations of this Association.
- H. To fix and enforce penalties, within the District, for violation of the Constitution and By-Laws, Policies and Procedures and Rules and Regulations of this Association within the limits prescribed by the By-Laws.
- I. In acting pursuant to the provisions of subsections D, E, F, G, and H of this Section, the District Committee shall act at a scheduled meeting, unless the Chairman of the District Committee shall determine that immediate disposition of the matter would be in the best interests of the District or the Association. In such event, the chairman of the District committee shall promptly convene a Hearing Panel to hear and determine such matter as expeditiously as possible. The membership of such Hearing Panel shall consist of five members of the District Committee designated by the Chairman for each such matter requiring expeditious disposition. No officer or member of the District Committee shall be eligible to serve upon such Hearing Panel in any matter involving such officer's or member's school or school district.
- J. To have general control of District Championship Contests and District Interscholastic Meets.
- K. To act with the Board of Directors in the transfer of schools from one district to another.
- L. A District Committee shall have such other powers within the District as are in keeping with the growth and needs of the Association and which are consistent with the Constitution and By-Laws, Policies and Procedures and Rules and Regulations of the P.I.A.A.
- M. A majority of its members shall constitute a quorum for the transaction of business of the District Committee except in cases where a three-fourths, or unanimous vote of the entire committee is required.

POLICY REGARDING PIAA-APPOINTMENT OF MEMBERS OF BOARD OF DIRECTORS AS INTER-DISTRICT PLAYOFF CONTESTS SITE MANAGERS AND THEIR RELATIVES SERVING AS EVENT PERSONNEL

PIAA shall provide for members of the PIAA Board of Directors to be appointed as site managers of inter-district playoff contests whenever the involved member is the Chairperson of that sport in the PIAA District in which the contest is being played, or has been designated by that chairperson.

PIAA shall restrict immediate family members of the members of the PIAA Board of Directors from serving as event personnel at inter-district playoff contests, except in urgent situations.

PIAA CONFLICT OF INTEREST STATEMENT

The Board of Directors of the Pennsylvania Interscholastic Athletic Association, Inc. (PIAA) requires that each person serving as a member of the Board of Directors, a District Committee, or an agent or employee of the PIAA, perform his or her duties without influence or the appearance of influence by any other business or financial interest of such person.

Potential conflicts of interest include, but are not limited to, a person's direct financial interest in a company or product which could be affected by a decision of the Board of Directors or a District Committee on which the person serves.

The PIAA is not critical of such interests. It merely requests that persons disqualify themselves from PIAA decisions on matters relating to such interests.

If a member of the Board of Directors, a District Committee, or an agent or employee of the PIAA, should have or develop a conflict of interest, such person shall:

- 1) Immediately identify the conflict in writing to the president and/or executive director, or the District Chairman, as applicable; and
- 2) Remove himself or herself from any discussion or decisions involving the matter in conflict.

In case of doubt about the existence of a conflict, a member should submit the question and the relevant facts to the president and/or executive director, or the District Chairman, as applicable, for a decision.

SEASONS AND OUT-OF-SEASONS RULES AND REGULATIONS

***** Section 4. Mixed Gender Participation.** PIAA strongly supports and encourages participation by both boys and girls in interscholastic athletics. Based upon real and demonstrable physical and competitive differences between similarly aged and trained high school boys and girls in athletic performances, PIAA recognizes that combining genders for competition purposes would have a chilling effect on female participation in interscholastic athletics. PIAA further recognizes that, historically, girls' participation has been much more limited than boys' participation. To promote participation by the historically underrepresented gender in a fair competitive environment, PIAA, therefore, classifies sports by gender and limits mixed gender participation as follows.

- A.** If a school has a Boys' Team in a sport, boys at the school are not eligible to play on the school's Girls' Team in that sport. If a school has a Girls' Team in a sport, girls at the school are not eligible to play on the school's Boys' Team in that sport. The Principal may waive this limitation for a girl seeking to play on a Boys' Team if the Principal believes that the girl's skill level is such that participation on the Girls' Team would not provide meaningful competition for the girl.
- B.** Girls may play on a Boys' Team if the student's school does not sponsor a comparable Girls' Team in that sport. **NOTE:** softball and baseball are not viewed

as being comparable sports. Despite some differences in rules, boys' volleyball and girls volleyball, as well as boys' lacrosse and girls' the Team to be noticeably more competitive than it would be without the boy's participation on the Team).

In considering whether to permit participation, with regard to factors 3 and 4, above, the Principal shall be guided by the following:

- a. Where there is a question as to the risk posed to opponents or to a possible significant competitive advantage to the Principal's Team, such questions should be resolved in favor of the health and safety of opponents and in favor of preventing significant competitive advantage.
- b. Due to the increased risk of injury to opponents in direct contact sports (field hockey, lacrosse, soccer and volleyball), particular scrutiny should be applied by the Principal to requests in these sports.

Notwithstanding any other provision in this Section, boys are permitted to participate on a Spirit Team without Principal approval.

D. Rules applicable to Mixed Gender Teams: Because PIAA does not have a Mixed Gender classification, the following provisions govern participation by Mixed Gender Teams:

1. for Post Season purposes, Mixed Gender Teams (other than in the sport of Spirit) shall compete only in the sport classifications designated for boys.
2. For enrollment classification purposes, a Mixed Gender Team shall be classified by using the school's enrollment number for whichever gender constitutes a majority of the Team members.
3. In the sport of volleyball, a Mixed Gender Team shall play during the boys' Regular Season and Post Season.

E. Where a student's gender is questioned or uncertain, the decision of the Principal as to the student's gender will be accepted by PIAA.

F. Nothing in this Section shall be interpreted to require a school to have a Mixed Gender Team where such participation would be inconsistent with the school's religious beliefs.

G. The refusal of a Team to participate in a Contest against a Mixed Gender Team shall result in forfeiture of the Contest by the Team which refuses to participate. In sports in which individual events or matches are conducted, refusal of a contestant to participate in any event or match will result in forfeiture of that event or match by that student and not by the Team.

***** GLOSSARY *****

BOYS' TEAM: A Team consisting of all boys.

GIRLS' TEAM: A Team consisting of all girls.

MIXED GENDER TEAM: A Team consisting of both boys and girls. Participation of both boys and girls on a Team in any Contest during a season causes the Team to be considered as a Mixed Gender Team for that season.

District 5 Policy on Forfeits

PIAA District V member schools develop their own Regular Season schedules in each sport through their own scheduling, joining local leagues, conferences and/or schedules prepared by a District Committee. Consent to accept such a schedule **commits** the school to participate in Contests as scheduled.

Understanding that when schools in District V have scheduled non-PIAA or out of District 5 competition that they can't always control that a game is rescheduled and played. Generally if games are not played they will be considered a "no contest" unless there are circumstances warranting a forfeit.

Except as otherwise noted, the following rules govern situations in which schools shall or may be required to forfeit a Contest.

1. The failure of a Team to participate in a Contest shall constitute an automatic forfeit, regardless of the reason(s) thereof, unless the school not participating convinces the District Committee and/or its Authorized Designee that its failure to participate was unavoidable, in which event the District Committee and/or its Authorized Designee may treat the matter as if the Contest had not been scheduled.
2. A forfeit constitutes a loss for the Team school not participating and a win for its opponent for purposes of records, standings, and eligibility for playoffs.
3. A forfeit is not subject to refusal by an opponent.
4. Schools may voluntarily agree to terminate a contract for a Contest, in which event the matter shall be treated as if the Contest had not been scheduled. In Districts in which scheduling is done by or pursuant to the authority of the District Committee, permission of the District Committee or its authorized designee shall be required for failure to participate to be treated as if the Contest had not been scheduled.
5. Schools may agree to reschedule a Contest which was not or will not be played at the scheduled time, in which event the failure to play the Contest at the originally scheduled time shall be treated as if the Contest had not been scheduled to be held at that time. In Districts in which scheduling is done by or pursuant to the authority of the District Committee, permission of the District Committee or its authorized designee shall also be required for rescheduling of a Contest.
6. When a Coach has been disqualified from a Contest but fails to leave the vicinity of the competition area, resulting in the termination of the Contest, the Contest shall be forfeited to the opponent.
7. Except as otherwise provided in "Forfeiture of Contests", provisions of the official rules for sports in which PIAA member schools participate, which relate to forfeits of Contests, shall apply according to their terms.

October 5, 1984, as amended January 29, 2005. If a school receives a forfeit from an opponent, the school receiving the forfeit may schedule another Regular Season Contest in lieu of the forfeited Contest. The school must then use the results of the played Contest, rather than the forfeit, for its record. The forfeiting school must still record a loss by forfeit.

2026-27 P.I.A.A. DISTRICT V RANKING SYSTEM

A. POINT SYSTEM – SPORTS WITH 6 CLASSIFICATIONS

1. A team receives 6 points for a win.
2. Bonus points are awarded on the following basis:
 - 1 point awarded for a win over a class A school, total of 7 points
 - 2 points awarded for a win over a class AA school, total of 8 points
 - 3 points awarded for a win over a class AAA school, total of 9 points
 - 4 points awarded for a win over a class AAAA school, total of 10 points
 - 5 points awarded for a win over a class AAAAA school, total of 11 points
 - 6 points awarded for a win over a class AAAAAA school, total of 12 points

B. POINT SYSTEM – SPORTS WITH 4 OR FEWER CLASSIFICATIONS

1. A team receives 4 points for a win
2. Bonus points are awarded on the following basis:
 - 1 point awarded for a win over a class A school, total 5 points
 - 2 points awarded for a win over a class AA school, total of 6 points
 - 3 points awarded for a win over a class AAA school, total of 7 points
 - 4 points awarded for a win over a class AAAA school, total of 8 points

C. ADDITIONAL POINT SYSTEM INFORMATION – ALL SPORTS

3. No points are awarded for a loss regardless of opponent's classification.
Victories over out of state opponents will receive the same bonus points from that sport's PIAA classification system. The Principal and/or Athletic Director will secure in writing from the out of state opponents the current enrollment of males and females eligible to participate from grades 10-12 in the year in which the contest will be held. District 5 schools shall list the enrollment beside the opponent's name on the District 5 Rating Sheet. Victories over non-P.I.A.A. opponents will receive the lowest point total awarded in that classification for a victory.
4. Tournament games, scrimmages, and exhibition games (example: alumni games) do not count in ranking.
5. Forfeiture of a contest will be governed by P.I.A.A. rules.
6. **Failure to play entire schedule could result in additional penalties (point deductions) per district committee rulings/decisions.**
7. Rankings are based on all school schedules that are turned into the District V Statistician by the first legal starting date for that sports season. If games are lost by a school because a scheduled opponent disbands their team before the first legal play date, they may schedule other games for ranking. If games are lost by a school because a scheduled opponent disbands their team after the first legal play date, they may receive forfeits for

the games lost.

8. In order to be considered for ranking purposes, in District 5 Playoffs, a minimum number of contests must be played against PIAA member schools or non-PIAA schools that are in good standing with their respective National Federation of State High School Association and member state high school association. It is the responsibility of District 5 member schools to insure that all contests submitted meet PIAA and District 5 rules:
 - Schools must complete a minimum of 50% of the PIAA maximum number of contests allowed as set forth in the PIAA Constitution & By-Laws.
 - Basketball & Volleyball - 11 contests
 - Baseball & Softball - 10 contests
 - Soccer & Tennis - 9 contests

B. TIE BREAKER SYSTEM FOR RANKING ONLY, APPLIED IN ORDER (Tournament games will not be used in any of the criteria listed below.

NEW SYSTEM

- A. Head to Head victor, if the teams played each other
- B. Winning percentage versus all common opponents in all games played (regardless of the number of times two schools play each other).
- C. Bonus Points as calculated by wins by defeated opponents divided by games played.
- D. Winning percentage calculated by wins divided by games played. Ties count as half.
- E. Greatest number of wins, excluding tournaments & exhibition games (example: Alumni Games)
- F. Coin toss at site convenient to both schools

C. If schools with records less than .500 are tied for the last slot on the playoff bracket and having the same rating, playoff games or matches will be held at a neutral site. Applies to all sports except Football.

D. RANKING AND PLAYOFF INFORMATION – INDIVIDUAL SPORTS

1. FOOTBALL

- a. Points from first 10 games count for ranking.
- b. Ranking is determined by total points accumulated. Total points will be divided by total games played.
- c. P.I.A.A. has all six classes for ranking purposes.

2. GIRLS VOLLEYBALL

- a. A minimum of 11 games played are necessary to qualify for playoffs.
- b. Ranking is determined by total points accumulated divided by the total games played, excluding tournaments, scrimmages, and exhibitions.
- c. P.I.A.A. has six classes for ranking purposes, Class A through Class AAAAAA

3. BOYS AND GIRLS SOCCER

- a. A minimum of 9 games played are necessary to qualify for playoffs.
- b. Ranking is determined by total points accumulated divided by the total games played, excluding tournaments, scrimmages, and exhibitions.
- d. P.I.A.A., has four classes for ranking purposes, Class A, Class AA, Class AAA, Class AAAA. Girls Class AA compete in District 6. There are four Boys Classes. AA will boys will

compete with District 8 in a regional.

4. BOYS AND GIRLS BASKETBALL

- a. Ranking is determined by total points accumulated divided by the total games played, excluding tournaments, scrimmages, and exhibitions.
- b. P.I.A.A. has all six classes for ranking purposes.

5. BASEBALL AND SOFTBALL

- a. A minimum of 10 games played are necessary to qualify for playoffs.
- b. Ranking is determined by total points accumulated divided by the total games played, excluding tournaments, scrimmages, and exhibitions.
- c. P.I.A.A. has six Boys and Girls classes for ranking purposes.

6. BOYS AND GIRLS TEAM TENNIS CHAMPIONSHIPS

- a. Ranking is determined by total points accumulated divided by the total games played, excluding tournaments, scrimmages, and exhibitions.
- b. The top four teams will play at the #1 team's court for boys and top four teams will meet at the #1 team's court for girls.
- c. P.I.A.A., for ranking purposes, has two classifications for Boys and Girls Tennis – Class AA and Class AAA.

7. TEAM WRESTLING CHAMPIONSHIP

- a. Ranking is determined by total points accumulated divided by the total matches played, excluding tournaments, scrimmages, and exhibitions.
- b. P.I.A.A., for ranking purposes, has two classifications for wrestling – Class AA and Class AAA.

9. NUMBER OF QUALIFIERS FOR DISTRICT 5 TEAM SPORT TOURNAMENTS

(As adopted at the January 28, 2026 committee meeting)

- a. 12+ teams at start of season = 8 team bracket
- b. 8-11 teams at start of season = 6 team bracket
- c. 7 or less teams at start of season = 4 team bracket
- d. Teams with .500 or better records will qualify and be added to the bracket
- e. Subregional tournaments will be setup in conjunctions with the other district(s) involved in the subregional

INDIVIDUAL STUDENT PARTICIPATION IN PIAA DISTRICT 5 TOURNAMENTS

(Cross Country, Golf, Boys Tennis Singles, Girls Tennis Singles, Track & Field)

1. The board of school directors of the participating high school must sanction the student's participation in the Tournament by Board resolution.
2. The board of school directors must approve individuals to serve as coaches of the activity.
3. The administration is to ensure that student athletes have physical examinations on file, names are added to an eligibility list, and where applicable, that their coaches have attended a rules interpretation meeting. In the event that an activity is to be started after the regular season has begun and the rules interpretation meeting was already held, it is the responsibility of the high school principal to notify the PIAA Executive Director and the District 5 Chairman.
4. The above regulations only apply to individuals entering into the District Tournament and representing District 5 in the state championships. Please note this does not negate Article VIII – Sections 5 & 6 of the PIAA Constitution that govern team championships.

Football: Champion Team receives trophy. Members of champion and runner-up teams receive individual awards (50 Maximum).

Golf: Champion Team receives trophy. Members of champion team and runner up team receive individual awards (10 maximum). Individual awards - 1 Boys and Girls Champion Plaque, 1 Boys State Qualifier Plaque.

Soccer Girls and Boys: Champion Team receives trophy. Members of champion and runner-up teams receive individual awards (25 maximum).

Softball: Champion Team receives trophy. Members of champion and runner-up teams receive individual awards (25 maximum).

Tennis: Singles and Doubles - Individual awards Champion and runner up Plaques.

Tennis, Team: Champion Team receive trophy. Members of champion and runner-up teams receive individual awards (maximum 10)

Track & Field Girls and Boys: Champion Team receive trophy. First six finishers in each event receive individual awards.

Volleyball: Champion Team receives trophy. Members of champion and runner-up teams receive individual awards (25 maximum).

Wrestling: Champion Team receives trophy. First three finishers in each weight class receive individual awards.

Wrestling, Team: Champion Team receives trophy. Members of champion and runner up teams receive individual awards (25 maximum).

Cheerleading: Overall Champion team (regardless of size) receives a trophy. Members of champion and runner-up teams receive individual awards (25 maximum).

District Champions will be awarded only when District 5 has four or more teams. When District 5 is hosting the Tournament with another District(s) to form a Sub-Regional, the winner will be declared Sub Regional Champions.

While the District Committee will pay for a maximum number of individual awards per sport as noted above, schools will have the opportunity to purchase additional individual awards should they have a need. In addition, every effort will be made to have some extra blank awards on site when a school has a larger than normal squad, so that all athletes can be honored appropriately at championship events.or

For subregional championship games in which no awards have been pre-planned with cooperating Districts and when no District 5 champion has been determined, the committee shall provide Championship Individual awards to a District 5

team that would win a subregional championship. A Team Trophy will also be purchased by the committee for schools that win subregional titles under the circumstances outlined above.
